At this time, only PEPS, Common Origination and Disbursement (COD), and the Schools Channel use the revised OPE ID format. All data transmissions between other Departmental systems (National Student Loan Data System, PELL, FFEL, Direct Loans, Campus-Based, Central Processing System, etc.) concerning additional locations which are greater than "99" must be transmitted using the main institution's OPE ID. The community will be notified as other systems are ready to process utilizing the revised OPE ID.
