Cohort Default Report Re-cap

The Fiscal Year (FY) 09 DRAFT will be released on the <u>Information for Financial Aid Professionals (IFAP)</u> website to postsecondary institutions participating in federal loan programs, February 14, 2011.

The FY09 OFFICIAL will be released on the <u>IFAP</u> website September 12, 2011.

In January 2011, the FY2008 3-year CDR estimate will be released on the IFAP website to participating postsecondary institutions.

Postsecondary institutions are assessed under the average rate unless there are less than 30 borrowers in repayment. If that is the case, three years of data is used.

3-year CDR Corrective Actions

- 1st year at 30% or higher create default prevention plan, create default prevention taskforce, submit to Federal Student Aid (FSA) for review
- 2nd year at 30% or higher review/revise default prevention plan, submit to FSA for review, FSA may require additional steps
- 3rd year at 30% or higher loss eligibility for Pell, ACG/Smart, Direct Loans

Postsecondary institutions are encouraged to set up a Default Prevention Team that includes senior school officials, representatives from all campus offices, and one student representative.


State Scholarship & Grant Programs

February

House-Passed Short-Term Budget Bill

President Obama signed the Continuing Resolution (CR) on December 22, 2010. This 45 day CR will fund the federal government through March 4, 2011.

The \$5.7 million needed to cover the Pell Grant shortfall is provided by the resolution. This measure ensures that the maximum Pell Grant will remain at \$5.500.
