### Office of Student Financial Assistance (OSFA) Sponsors Mapping Your Future

June 2011

On July 1, 2011, **Mapping Your Future** will offer a new “Membership Program,” providing schools, companies, and other organizations a new way to participate in **Mapping Your Future** as well as continuing its support for student and family services.

OSFA is pleased to continue its sponsorship of **Mapping Your Future**. Florida schools will not be required to pay a membership fee. However, after July 1, schools in non-sponsored states will be required to pay a membership fee to access “Online Counseling” and other services, such as college preparation, career exploration, money management, and financial aid.

**Mapping Your Future** developed the new “Membership Program” following legislative changes over the past few years which impacted financial aid structures. The new program accommodates those changes, provides access to new services based on new higher education challenges, and enables organizations to support public service through their membership.

**Mapping Your Future** offers this tool to serve students and families, which emphasizes rapid response to industry changes and customer needs, provides information and services that support college access and success, encourages collaboration through reliance on volunteer support, and enables innovation through technological solutions.


State scholarship and grant applicants' initial and renewal notifications are viewable on the students' financial aid recipient history for:

- **June 30** — State of Florida fiscal year ends for state scholarship and grant programs

# Important Announcements

## U.S. Department of Education (ED) clarifies effective date of new R2T4 regulations

An [electronic announcement](#), published on May 6, 2011, by ED, provided critical information in a question and answer format about the July 1, 2011, effective date for the new return of Title IV funds (R2T4) rules.

ED indicated that the new R2T4 requirements are applicable to students who withdraw from payment periods or periods of enrollment that begin on or after July 1, 2011. Also noted was that new rules do not apply to students who withdraw from a 2011 crossover payment period even if the student received Title IV, HEA program funds from the 2011-12 award year for that crossover payment period.

This guidance will help schools prepare to implement new R2T4 rules. These new rules cover programs offered in modules and expand the definition of schools that are considered "required to take attendance" for R2T4 purposes.
