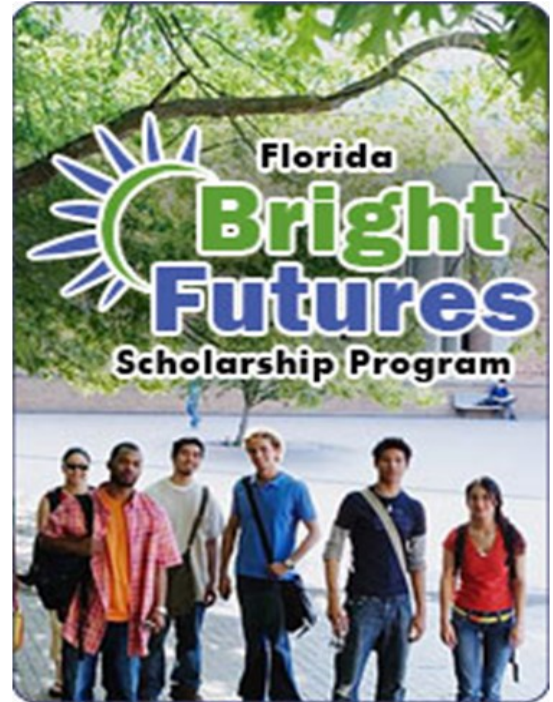

- Term 2 refunds/reconciliation due to OSFA within 60 days after the last day of drop/add.

## March

- March 1 – Program compliance audits due from participating private institutions.

- Florida Bright Futures Scholarship Program initial 7th semester evaluations and award notifications are posted to students' online Financial Aid Recipient History screens.

## New Federal Family Education Loan Program (FFELP)

### Lender and Servicer Audit Guides

The United States Department of Education (ED), Office of Inspector General, published new audit guides for lenders and servicers participating in FFELP. The new audit guides are effective for fiscal years ending on or after June 30, 2011, and supersede the previous guides published in December 1996.

## Trial 3-year Cohort Default Rate Released by ED

ED [released](#) a "trial" 3-year cohort default rate (CDR) for fiscal year (FY) 2008 to assist schools in understanding the impact of the new 3-year CDR calculation. ED notes that it is providing the trial rates for informational purposes only and no benefits or sanctions apply to the trial rates.
