### Public Service Loan Forgiveness (PSLF)

The OSFA Outreach Team is available to assist with PSLF training needs. The PSLF Program was established to encourage individuals to enter and continue in full-time public service employment by forgiving the remaining balance of their William D. Ford Federal Direct Loan Program loans (Direct Loans) after the borrower has made 120 qualifying monthly payments (beginning any time after October 1, 2007) while employed full-time by a public service organization. To qualify, the borrower must be employed full-time by a public service organization when the required 120 monthly loan payments on the Direct Loan are completed and at the time of application. 
## **State Scholarship & Grant Programs**

### 2011 Florida Legislative Session

The 2011 session started March 8, 2011 and will end May 6, 2011.

#### **Budget**

After the session ends, the budget is submitted to the Governor for review and signature. When the budget is signed, OSFA will notify all postsecondary institutions of the 2011-2012 appropriation amounts for state scholarship and grant programs. The OSFA website is updated in July 2011 to reflect the 2011 Legislative changes.

# ED provides guidance on participation in the William D. Ford Federal Direct Loan Program

On March 22, 2011, ED provided information for participation in the William D. Ford Federal Direct Loan Program and guidance on issues related to school participation in the Direct Loan Program.

The following topics are discussed in this letter:

- Participation in one or more components of the Direct Loan Program
- Limiting student or parent borrowing
- Denial of Direct PLUS Loans based on adverse credit
- Awarding additional Direct Unsubsidized Loan funds to dependent students
- Student FAFSA required for parent Direct PLUS Loans

With the exception of the new requirement that a student complete a *Free Application for Federal Student Aid* (FAFSA) before the parent can receive a Direct PLUS Loan, schools participating in the Direct Loan Program for the first time are reminded that the guidance in the letter is consistent with the policies that applied to schools under the Federal Family Education Loan (FFEL) Program. ### New Ability to Benefit Regulations

ED addresses, in the Federal Register of October 29, 2010, improving integrity in the programs authorized under Title IV of the Higher Education Act of 1965, as amended (HEA), by amending the regulations for Institutional Eligibility under the HEA. ## **Important Announcements**

#### Direct Loan Cash Refund Process

Direct Loan funds are not student-specific, but are program year-specific. This means that when one student will not use the funds or returns them to the school, the funds can be disbursed to other eligible students who are eligible for Direct Loans in the same Direct Loan program year. If the funds cannot be disbursed within the regulatory timeframes, they must be returned. To review the annual reminder please visit <a href="#">IFAP</a>.
