### 2011-12 Loan Volume Reporting Requirement

2012

June

The 2012 General Appropriations Act (GAA) proviso language requires the reporting of loans disbursed and number of students receiving loan funds by postsecondary institutions receiving Office of Student Financial Assistance (OSFA) administered state scholarships and/or grant funds during the 2011-12 academic year. Postsecondary institutions must report this information to the Department of Education (Department) by **September 1, 2012**, in the format specified by the Department. The Department is then required to report this submitted information to the Florida Legislature.

To assist you in meeting this Legislative reporting requirement, we will continue to utilize the online reporting process developed last year, updated with the detailed loan type information required (e.g., TEACH grant/scholarship loans, all Stafford, Perkins, and Plus loans). A memo specifying these changes and instructions for completing the reporting is forthcoming once reporting is available July 1, 2012.

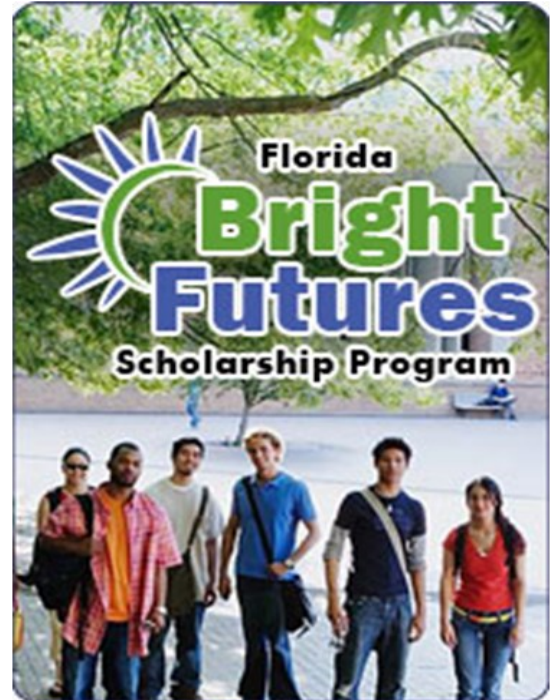

[The Gainful Employment Operations Manual](#) contains information about the 2010 and 2011 gainful employment regulations. It is intended for institutions that participate in the federal student assistance programs authorized under Title IV of the Higher Education Act of 1965, as amended (HEA). Within this manual, you will find guidance regarding implementation and compliance with each aspect of the gainful employment regulations.

## Program Integrity Questions and Answers (Q&A) Website Update

As described in E-Announcement 2011-09-02, the Office of Postsecondary Education (OPE) maintains a website containing Q&As pertaining to the Program Integrity final regulations that were published on October 29, 2010. OPE recently updated this website with regards to the following topics:
