#### **Bridging The Gap**

Recent data collected by the U.S. Department of Education (ED) states that there is a strong correlation between completion of the *Free Application for Federal Student Aid* (FAFSA) and college enrollment, especially within low-income populations. Filing a FAFSA is the gateway to accessing federal, state, and institutional funds for college.

As Financial Aid Administrators (FAA), you see the outcome of these statistics with the students you serve daily.

At the Office of Student Financial Assistance (OSFA), we work diligently to bridge the gap for those schools and students who do NOT have strong FAFSA completion rates. With the help of the FAFSA Completion Project, offered by Federal Student Aid, secondary schools can now be privy to the number of students who have completed a FAFSA and reach out to those seniors.

The data collected is displayed in spreadsheets, broken down by state or territory, and includes the high school name and city. At the postsecondary level, you are aware of high schools that feed into your institution on a regular basis. OSFA's Outreach Representatives can provide assistance to the school counselors and students.

We strongly encourage you to review the data from the secondary schools in your local region and then target your financial aid office outreach to those schools that may be struggling to get their students enrolled in college. # State Scholarship & Grant Programs

#### May

**May** – Postsecondary institutions begin Grade and Hours reporting for previous summer, fall, and spring terms. Due to OSFA 30 days after the last day of classes or June 30, whichever comes first.

**May 1** – The *2013-14 Renewal Application for Institutional Eligibility* opens. The deadline to file is June 7.

**May 17** – Postsecondary institutions send Grade and Hours to OSFA for centralized programs:


- Florida Bright Futures Scholarship Program

#### Implementation of the Financial Aid Shopping Sheet

On July 24, 2012, Secretary Arne Duncan posted an <u>open letter to college presidents</u> asking for the voluntary adoption of the Financial Aid Shopping Sheet. On July 25, the U.S. Department of Education (ED) published <u>Dear Colleague Letter GEN-12-12</u>, releasing the Shopping Sheet format and requesting institutional commitment to use this format. As of December 2012, <u>nearly 600 institutions</u> committed to adopting the Shopping Sheet. ED is continuing its work with institutions and software developers to provide guidance regarding the implementation of the Shopping Sheet.


