### Providing Support to Undocumented or Ineligible Non-Citizens

Many undocumented or ineligible non-citizens need assistance with finding money to pursue higher education. If you are assisting **ineligible** noncitizens, we suggest that you encourage them to complete the *Free Application for Federal Student Aid* (FAFSA) and submit it for processing. These students may be eligible for state or institutional aid.

Aid is available for undocumented students through a variety of avenues. It will take the students time, hard work, and effort, but if you encourage them to pursue these opportunities, they should find sufficient monies to assist them in pursuing a higher education.

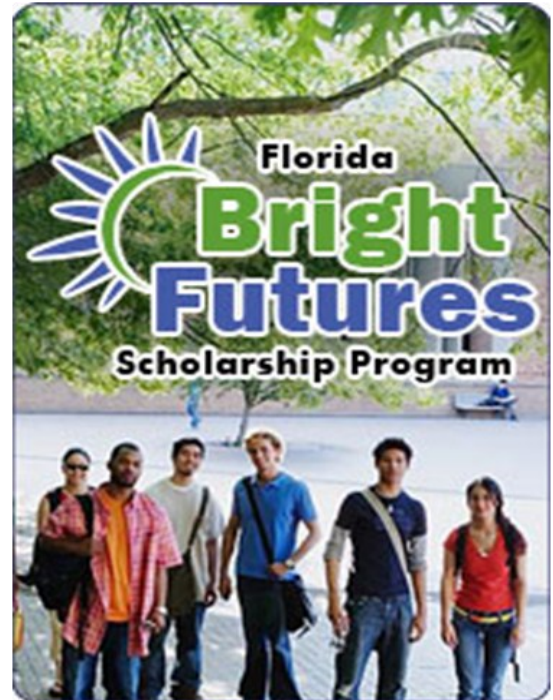
## January
