# 2013 Florida Legislative Session State Scholarships and Grants

The 2013 Florida Legislative Session ended May 3, 2013. Legislators passed seven bills that affect state-funded financial aid programs administered by the Office of Student Financial Assistance.

These bills were either approved by the Governor or are waiting for his action. Governor Scott has 15 days from receipt of these bills to sign them into law, veto, or let the bills become law without his signature. This "Reality Check" calculator will provide your students with a general snapshot of their financial futures.

While local salaries, wages and lifestyle costs vary throughout the United States, the internal data used in this calculator is based on national averages. The results will indicate a ballpark relationship between students' expenses and the incomes they will need to support their lifestyles.

The internal data in this calculator is adapted from several sources, including the annual Consumer Expenditure Survey from the Bureau of Labor Statistics.

The upcoming deadline for renewal application for all postsecondary institutions to participate in state programs for the next academic year is June 7th.

**June 30** – or 30 days after the last day of classes (whichever comes first) - Grade and Hours Report deadline

**June 30** – State of Florida fiscal year ends for state scholarship and grant programs.

#### July

**July 1** – State of Florida fiscal year begins for state scholarship and grant programs.

MappingXpress, a new online service on Mapping Your Future, provides schools and other organizations a better way to collect documents from students. MappingXpress enables schools to streamline document (mainly relating to verification) collection and provides students a convenient and secure way to quickly respond to the request.

School financial aid office or business professionals can retrieve those documents securely from their access area on Mapping Your Future.

MappingXpress can help schools with document collection for different business processes, including:

- Verification
- C-code resolutions
- Enrollment and admission applications
- Scholarship applications
- Grant applications
- Work-study paperwork/applications
- Employment applications
- Any process requiring the collection of documentation

Mapping Your Future developed MappingXpress in response to requests and feedback received from schools. This service will help decrease the burden on busy financial aid offices as requirements to collect documentation from students continues to increase. Recent federal regulations have mandated more substantiation, which requires schools to obtain more documents from students and parents

The notification will be generated once a month through August and is also posted to the students' online FARHS. It is our hope that this reminder will help train students to review and update their online FARHSs so the postsecondary institutions appear correctly on OSFA's Master Eligibility Lists.
