## Update to 2013 Florida Legislative Session Tracking for State Scholarships and Grants

The 2013 Florida Legislative Session commenced March 5, 2013. Well into the session, the Office of Student Financial Assistance (OSFA) tracked 48 bills out of over 1,800 bills that may affect state scholarship and grant programs or postsecondary institutions.

You may track all 2013 Florida Legislative bills via Online Sunshine at <u>www.leg.state.fl.us/Welcome/</u>. Filed bills usually are assigned to at least three committees. Once the bill is approved by each committee, the bill is presented for vote by the chamber (either House or Senate), and then moved to the next chamber for approval or denial. If a bill is passed by both House and Senate, the bill is presented to the Governor. He may sign the bill into law, let the bill become law without his signature, or veto the bill.

To assist in promoting student access and choice for postsecondary education, NCHER is providing new online resources. The Income-Driven Repayment Comparison brochure was updated and a PowerPoint presentation was developed as a companion piece to help explain Income-Based Repayment (IBR), Income-Contingent Repayment (ICR), and Pay As You Earn repayment plans. Both of these resource documents, developed by the NCHER Regulations Committee, may be used together or separately for both internal training and reference purposes. The PowerPoint also includes speaker notes and was developed especially for schools to explain income-driven repayment plans to students and borrowers.

Grade and Hours Reports are due to OSFA 30 days after the last day of classes or June 30, whichever comes first. Renewal notifications are posted to students' financial aid history web pages.

- May 1 The 2012-13 Renewal Application for Institutional Eligibility opens. The **Deadline** to file is June 7.
- May 15 Processing Deadline to file the Free Application for Federal Student Aid (FAFSA) for the Rosewood Family Scholarship Fund and the José Martí Scholarship Challenge Grant for initial and renewal students via www.fafsa.ed.gov
- May 30 Deadline for current year Bright Futures reinstatement/restoration applicants to apply for the 2012-13 academic year via:



# Office of Student Financial Assistance (OSFA)

### File Transfer Protocol (FTP) Setup

Beginning with the 2013-14 academic year, any postsecondary institution that is determined eligible for state scholarships and grants will be required to utilize the OSFA FTP for file up/downloads from the State Student Financial Aid Database (SSFAD). Only files for your institution's students of record (per the SSFAD) will be provided. If your institution does not need to up/download files from OSFA, an FTP account is not necessary, and you will continue to be able to determine eligibility and disburse students via the existing manual process.

On behalf of your institution, you may request that OSFA provide access capability to transmit files via OSFA FTP. Forms are available online. Visit our website at www.floridastudentfinancialaid.org/SSFAD/

home/uamain.htm. Select the Postsecondary Institutions tab, and then access the forms under Disbursement Reporting, Eligibility Determination Lists, or Institution Information.
