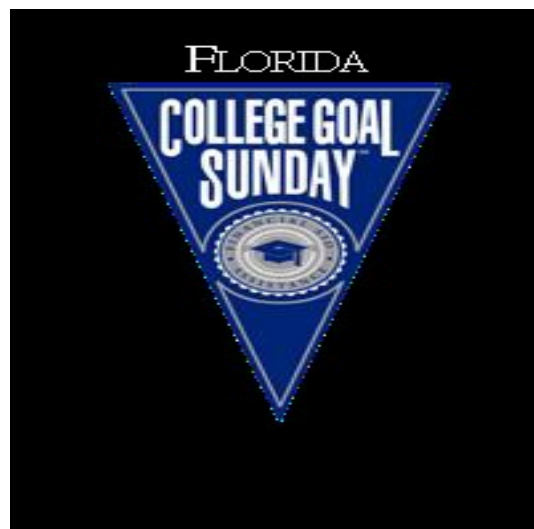

## Remedial Coursework

The below information is taken, in part, from information Mr. Bartnicki shared with participants at the 2013 NASFAA conference in July.

I have been getting lots of questions from schools in Florida regarding a school's ability to pay Title IV (TIV) aid for remedial coursework due to some recent changes in Florida state regulation with respect to remedial coursework. In working with policy and several schools, policy confirmed the following guidance regarding a student's eligibility to be paid TIV aid for remedial coursework. Though this has been an issue primarily with my Florida schools it may prove beneficial to other schools as well.

As long as a student is officially admitted into a TIV eligible program of study and considered a regular student, that student can be paid TIV aid for remedial coursework up to the aggregate limits allowed (30 semester hours, 45 quarter hours, and 900 clock hours) regardless if the school required the student to take remedial coursework, recommended the student take remedial coursework, or if the student themselves simply decided to take remedial coursework. Since remedial coursework will never be a formal part of the student's program of study (not part of the hour requirements of the program since no credit or reduced credit), by definition they are not a part of the program of study and are an exception to our normal rule that TIV will only pay for coursework that is part of a student's program of study for the purposes of seeking a degree/certificate.

# State Scholarship & Grant Programs

## Deferred Action for Childhood Arrivals (DACA) Students and State Programs Eligibility

For state grants and scholarship purposes, students must be Florida residents and U.S. citizens or eligible non-citizens. Non-U.S. citizens who have been granted withholding of deportation status shall also be considered eligible to establish Florida residency for tuition purposes. However, these students will not qualify for state grants and scholarships until they meet residency and citizenship requirements set forth in State Board of Education Rules 6A-20.03 and 6A-10.044.

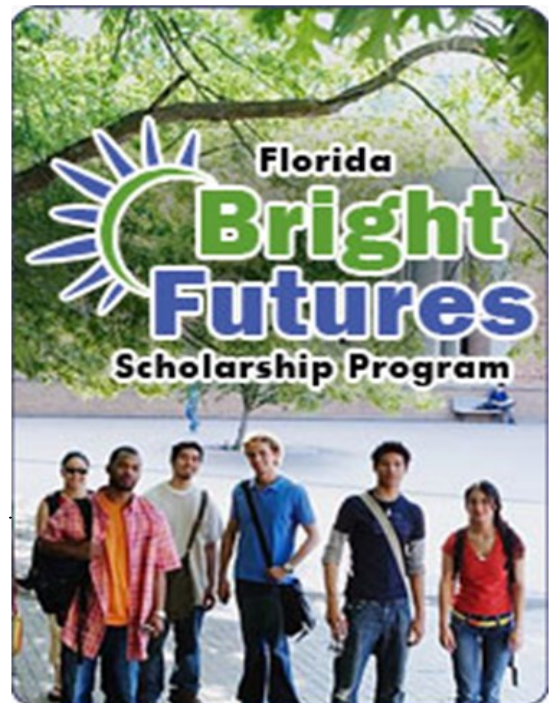
Institutions send reports of disbursement activity to the Florida Department of Education, Office of Student Financial Assistance. Disbursement Eligibility Reports (DER) are due to OSFA 30 days after the last day of drop/add.

## November

Bright Futures Academic Top Scholars awardees are notified of their eligibility via their online Financial Aid Recipient History. Academic Top Scholars will receive a cost per credit hour award in addition to the Florida Academic Scholars award.

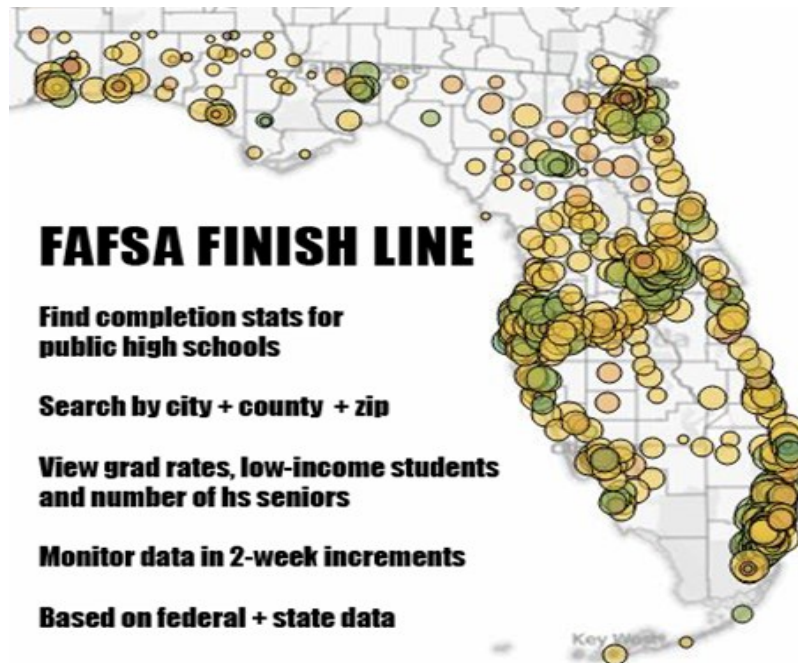

## Distribution of FY 2010 3-Year Official Default Rates

On September 23, 2013, the U.S. Department of Education (ED) distributed the FY 2010 3-Year official cohort default rate (CDR) notification packages to all eligible domestic and foreign schools enrolled in the Electronic Cohort Default Rate (eCDR) process, via the Student Aid Internet Gateway (SAIG). ED previously distributed the 2-Year Official Cohort Default Rates separately on September 16, 2013 to schools only.

This information was sent to the SAIG mailbox for the destination point designated by the school. Each eCDR package contained the following:

- Cover Letter (message class SHDRLROP),
- Reader-Friendly Loan Record Detail Report (message class SHCDRROP), and
- Extract-Type Loan Record Detail Report (message class SHCDREOP).

ED did not send eCDR notification packages to any school not enrolled in eCDR. Enrolled schools may download their cohort default rate and accompanying Loan Record Detail Reports from the National Student Loan Data System (NSLDS) via the [NSLDS Professional Access Web site](#).

**Note:** Any school that did not have a borrower in repayment, during the current or any of the past cohort default rate periods, will **not** receive a FY 2010 3-Year official cohort default rate notification package. These schools are considered to have no cohort default rate data and no cohort default rate. Guaranty agency rates were provided via e-mail. Lender rates were provided via postal service.

The time period for **appealing** the FY 2010 3-Year Official Cohort Default Rates under 34 C.F.R Part 668, Subpart M began October 1, 2013 for all schools. For specific information (including user guides) regarding eCDR Appeals, visit the [eCDR Appeals Web site](#).
