# **Important Announcements**

## Federal Student Loan Interest Rates

Effective July 1, 2013

**For undergraduates**, the Direct Loan interest rate for subsidized and unsubsidized loans is 3.86 percent.

**For graduate/professional students** who borrow a Direct Unsubsidized Loan, the interest rate is 5.41 percent.

For parents or graduate/professional students who borrow a Direct PLUS Loan, the interest rate is 6.41 percent.

Direct Consolidation Loans will continue to have a weighted average interest rate, but the cap of 8.25 percent was removed.

## **Legislation Reminder**

SB 1076 — Effective July 1, 2013. Signed by Governor Scott on April 22, 2013.

• Repeals FAFSA requirement for Florida Bright Futures Scholarship Program funding.

SB 1720 — Effective July 1, 2013. Signed by Governor Scott on May 20, 2013.

 Repeals the FAFSA requirement for the Florida Resident Access Grant Program, and the Access to Better Learning and Education Grant Program.
