DATES to NOTE:

December 25: OSFA office closed.

December: Program funds sent to eligible PSIs for Term 2.

January: Term 1 semester and quarter refunds of BF dropped/withdrawn credits funds are due within 30 days of the institution's last day of the term.

Term 2 DERs are due 30 days after the last day of drop/add.

State Programs Guide:

The Office of Student Financial Assistance (OSFA) has reorganized the *Postsecondary Institution Guide to the State Student Financial Aid Database (SSFAD)*. Over the years, needs of financial aid professionals have changed.

OSFA will focus directly on those needs and provide guidance to the most frequently asked questions. Instead of one guide, financial aid professionals will find a series of "selfhelp" resources designed to guide the users through one facet of the SSFAD at a time.

These resources will be updated frequently (see the revision date in the footer of each resource) and resources will be added or deleted as necessary.

Outreach Services Update

In the spring semester, the Outreach Unit will continue to coordinate FAFSA lab requests from high schools, organizations and other agencies at regional postsecondary institutions.

In addition, high school and transferring postsecondary students will be comparing financial aid award packages and finalizing their school choices. Reading through a financial aid award letter (hardcopy or electronic) can be confusing.

Most financial aid award packages may now contain student loans. The student will have the option to "decline" or "accept" student loans. If a student accepts the loans, he/she must understand it will need to be REPAID. Unlike scholarships and grants which do not have to be repaid, student loans follow the student throughout his/her adult life until paid in full.

The Outreach Unit will be offering webinars for students at all grade levels to help them understand the award letter, financial aid package details, and how to compare institutional financial aid award packages.
