"Stay, Stop or Drop"

OP		According to the <u>information</u> recently released by EAB (formerly Education Advisory Board), students who lose financial aid are more likely to leave
AID	2	college. EAB's findings include:
TURE	2 3	⇒ Students who lose an average of between \$1,500 and \$2,000 of finan- cial aid dollars are three percentage points more likely to leave college when compared to their peers.
	4	⇒ Students who lose an average of \$4,000 of financial aid dollars are more than four percentage points more likely to leave college when compared to their peers.

⇒ Students who lose over \$10,000 financial aid dollars are nineteen percentage points more likely to leave college when compared to their peers.

Students often lose financial aid due to making uneducated decisions regarding their enrollment. The key is to reach these students before decisions are made. OSFA's "Stay, Stop or Drop" information campaign addresses key issues that students need to consider prior to making decisions that will impact their pursuit of higher education. ⇒ The Florida Reinstatement/Restoration Application for state funding is now available for next academic year.

February/March

- ⇒ Term 2 refunds/reconciliation due to OSFA within 60 days after the last day of drop/add.
- ⇒ Program compliance audits due from participating private institutions.
- \Rightarrow Program funds sent to eligible PSIs for Term 3.
