FREE WEBINARS & FINANCIAL AID COUNSELING

Bright Futures Drop/Withdrawal Funds

- Students are required to repay the Bright Futures portion of the cost of any courses dropped or withdrawn after the last day of drop/add
- Students repay the institution
- Whether the student has paid the institution, the institution is required to remit funds to OSFA within 30 days of the institution's last day of each term

Grade and Hour Report

- Populated with same students you submitted on your DERs at the beginning of each term
- Submit institutional undergraduate cumulative GPA and earned hours for all disbursed students for the fall and spring of the academic year
- Due 30 days after the end of spring term, or by June 30 whichever is earlier

Reconciliation

- Reconciliation of all monies for the academic year due by June 1.
- Due 60 days after the institution's last day of drop/add
- All monies for the academic year are reconciled
- Carry-over of funds to next academic year not permitted

Institutional Renewal

- Institutions required to apply for renewal to participate in state financial aid annually
- Online application opens May 1 Due June 6
- Most data prefilled
- Update any changes
- Private institutions provide term dates, cost of attendance and tuition/fees for 2017-18
- Look for memo to be sent end of April
