# Navigating Your Financial Future (NyFF)



## Hot Spots

Whether you are sitting at the coffee shop waiting for a friend or sitting in the airport waiting for a plane, nothing beats the convenience of connecting your laptop to a free Internet hot spot! But where there is convenience, there is also security risk.

Many public wireless access points, commonly referred to as “hot spots,” are not configured to protect information sent between your computer and the Internet; therefore, it can be very easy for people sitting nearby to gain access to the data in transit. This means they may be able to read everything sent and received by your computer, including credit card numbers and passwords. Here are ways that you can reduce your risk and protect your information when you are in public:

**Turn off wireless when not needed.** This simple step can significantly reduce the risk of identity theft.

**Disable File Sharing.** It can be dangerous when you are connected to public networks. Always disable file sharing when connecting to a public network.

**Do not look now, but is that guy behind you watching over your shoulder?** Using your computer in public makes it very easy for others to “shoulder surf” and see what you are doing. Attackers don’t need sophisticated cracking programs if they can simply read your screen and watch you type.

**Do not allow automatic connections.** The danger of enabling this setting is that your computer may automatically (without even notifying you) connect to any available network.

Most users are unaware of the threats they are exposed to when they use open Wi-Fi connections. It is up to you to protect your information.

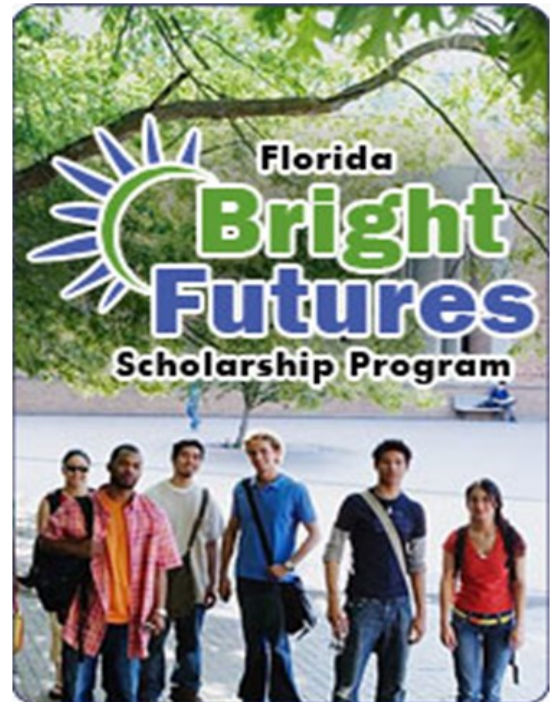

# Important Announcements

## Direct Loan Processing Information - Making Disbursement Adjustments and Reducing Direct Loan Awards to Zero

In this announcement, guidance is provided on the following two processes: making disbursement adjustments to William D. Ford Federal Direct Loan (Direct Loan) awards and reducing Direct Loan awards to zero (which effectively means that the Direct Loan is cancelled/inactivated). Disbursement adjustments are made or loans are reduced because –

- The borrower returned the money and requested all or a portion of the loan be cancelled within the regulatory timeframes.
- The school cancelled all or a portion of the loan to comply with statutory or regulatory requirements.
- The school is correcting reporting errors.

## Final rules on Program Integrity Issues published by ED

The Department of Education (ED) issued [final rules](#) in the Federal Register on a group of topics identified as "Program Integrity Issues" on October 29, 2010. All of the rules are effective July 1, 2011, except for changes in the verification requirements. Verification requirement rules will be effective July 1, 2012. These final rules impact public, private nonprofit and for-profit schools. It is imperative that all schools carefully review the updated rules to determine if changes need to be made to current institutional policies, procedures, and systems.
