- Options available after defaulting on a student loan

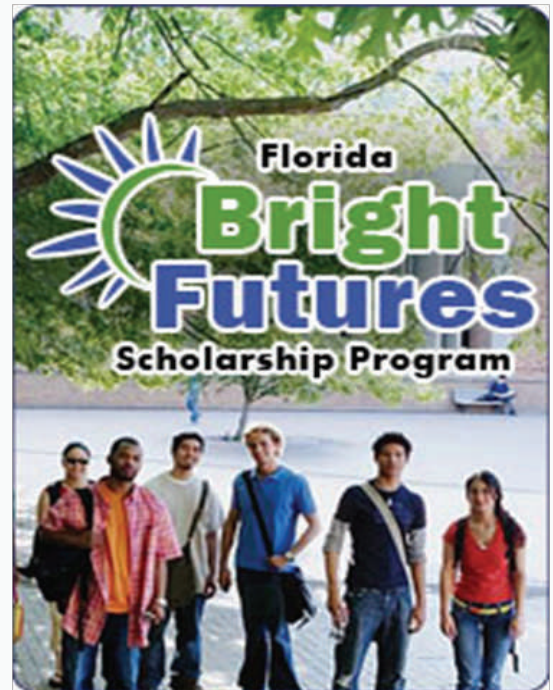
The deadline for Term 2 DERs—30 days after the end of the drop/add period—is fast approaching!

Florida College System Celebrates Success

The Florida College System experienced a successful year in 2009, despite the state's budgetary challenges. Florida's Division of Community Colleges, officially titled the Division of Florida Colleges last year, led the nation's southeast region in graduation and progression rates as well as maintaining top ranks for leading America's more than 1,200 community colleges in an array of degree categories, which included: Total Associate Degrees, Number of Associate Degrees awarded to minorities, Degrees awarded to African-American students, Health Professions and Related Sciences Degrees, and Nursing, Liberal Arts and Sciences, General Students and Humanities Degrees.

Florida's Colleges continued to serve as the primary point of access to higher education in Florida, with 58 percent of the state's high school graduates pursuing postsecondary education beginning at a community college. Eighty-one percent of freshman and sophomore minority students in public higher education attend one of Florida's 28 community colleges. Last year also saw the creation of 16 new baccalaureate degree programs within seven Florida colleges, as approved by the State Board of Education, to address the growing economic challenges of communities throughout the state. Additionally, with the signing of the new GI Bill, Florida's colleges experienced a 76 percent increase in veteran enrollment.

Another merit for Florida's colleges, the caliber of students, also proved strong last year with 92 outstanding college students honored as members of the 2009 Phi Theta Kappa all-Florida Academic Team. IRS Data Populating

Federal Student Aid is pleased to announce the implementation of the Internal Revenue Service (IRS) Data Retrieval process for initial and renewal web applications on the 2009-2010 FAFSA, beginning **January 28, 2010**. The IRS Data Retrieval process enables Title IV student aid applicants and parents of dependent applicants to transfer certain tax return information from an IRS Web site directly to their 2009-10 FAFSA web application.
