#### **Online FFELP Reports**

OSFA's new Claim Received Date (Claim Recd Date#) column in the Delinquency Loan Details Report is a great resource for our institutional partners. This new column can be an integral part of your institution's late-stage delinquency efforts and hopefully assist students avoid default.

On the *Delinquent Loan Details Report and Denominator Subset - Delinquent Borrower Details Report,* the total number of borrowers and the total number of loans have been added at the end of each report. Our new column, Claim Recd Date#, is located between the Days Delinquent and the Current Payment Amount columns. View this and many other valuable reports at our Online FFELP Reports website. # 2010-11 Critical Teacher Shortage (CTS) Student Loan Forgiveness and Tuition Reimbursement Program Funding

This year's legislative session appropriated no budget for the 2010-11 year for two programs that assisted employees in Florida publicly-funded schools with educational funding: the CTS Student Loan Forgiveness program and CTS Tuition Reimbursement program. The Office of Student Financial Assistance (OSFA) will therefore not be providing awards to initial or renewing teachers for their CTS teaching service.

Listed below are additional financial assistance programs for teachers that may be of interest to the teachers.

#### Loan Forgiveness:

• The Florida Department of Education, OSFA continues to administer the **Stafford Loan Forgiveness Program for Teachers** to assist with educational funding which may provide up to \$17,500 to teachers in principal and interest on Federal Family Education Loans and/or Direct Loans for teaching for five consecutive years in a designated low income school. Contact OSFA Customer Service at OSFAStudentLoans@fldoe.org or call our toll-free number at 1-800-366-3475, or visit the Federal Student Aid <u>website</u> for qualifications and a listing of eligible low-income schools.

• There is a new **Federal loan forgiveness program for public service employees**. Under this program, the amount forgiven is the remaining outstanding balance of principal and accrued interest on an eligible *Direct Loan* for a borrower who is not in default and who makes 120 monthly payments on the loan after October 1, 2007. The borrower must be employed full-time in a public service job during the same period in which the qualifying payments are made and at the time that the cancellation is granted. #### **Tuition Reimbursement:**

• Through the College Cost Reduction and Access Act of 2007, Congress created the **Teacher Education Assistance for College and Higher Education (TEACH) Grant Program** that provides grants of up to \$4,000 per year to students who intend to teach in a public or private elementary or secondary school that serves students from low-income families. #### National SMART Grant Program's List of Eligible Majors for Award Year 2010-11

GEN-10-12 provides the list of academic majors eligible for the National Science and Mathematics Access to Retain Talent (SMART) Grant Program for the 2010-11 award year. The final regulations for the National SMART Grant Program, which were published on October 29, 2007, provided a mechanism for institutions of higher education to request that additional majors be designated as eligible majors for which otherwise eligible students could receive a National SMART Grant. Additionally, final regulations published on November 23, 2009, provide a process by which an institution may request designation of a qualifying liberal arts curriculum as a National SMART Granteligible major.
