- Elimination of the Child Care Provider Loan Forgiveness Program.
- Revisions in Permitted and Prohibited Activities.
- Student Consumer Information.
- Extenuating Circumstances in Adverse Credit Determinations.
- In-School and Post-Enrollment Deferments for PLUS Loans.
- Loan Forgiveness Program for Service in Areas of National Need.

**Dear Colleague Letter (DCL) ID**: **ANN-09-05** announces the newly redesigned FSA COACH, an introductory self-paced Web-based tutorial on federal student aid administration. The new and improved editions of FSA COACH, is for both for domestic and foreign schools as has been redesigned and fully updated for the 2008-2009 Award Year. The courses are available on the Information for Financial Aid Professionals (IFAP) Web site at http://www.ifap.ed.gov/ifap/fsacoach.jsp.

The Economic Stimulus Act of 2008 (Public Law 110-185) provided a tax credit against 2008 tax liability to most taxpayers based on income and tax liability information reported on 2007 federal income tax returns. Section 101(a) of Public Law 110-185 amends section 6428 of the Internal Revenue Code of 1986 to provide for the economic stimulus payments to taxpayers, however, section 101(d) provides that the value of a stimulus payment is not considered as income or as a resource in determining an individual's eligibility for any program financed with Federal funds. Therefore, the Department has determined that any amounts of stimulus payments received last summer, are excluded from the EFC calculation. Applicants for Federal student aid should not report these stimulus payments either as income or untaxed income on their 2009-2010 FAFSA. Click here or deadlines dates.

## **Online FFELP Reports**

The Office of Student Financial Assistance has a wonderful reporting tool to assist schools and Lenders in managing their Cohort Default Rate and monitoring their OSFA volume.

<u>Default Prevention/Aversion Reports</u> - Information about borrowers who are withdrawn, graduated or delinquent. These reports can be used for mailouts.

Defaulted Borrower Reports- These reports provide detailed information regarding a borrower and their defaulted loans. Use Name and address reports for letter campaigns.

<u>Cohort Default Rate Reports</u>- Information for calculating estimated cohort default rates. Borrowers in the numerator and denominator have been broken into smaller subsets for additional research and resolution.

Lender Reports- These reports include summary information associated with the loan guarantee process. They provide a snapshot of FFELP volume by school and by loan program type

Entrance & Exit Counseling Reports- These reports include a list of students who have completed their required entrance or exit exam.

<u>NyFF Workshop Reports</u> -These reports include a list of students who have participated in various NyFF workshops. Contact your regional <u>OSFA Representative</u> for details.
