### Net Price Calculator

The release of the **net price calculator template**, a unique tool used to ascertain a student's eligibility for receipt of financial assistance, has been announced by the United State Department of Education's (ED's) Office of Postsecondary Education and The National Center for Education Statistics.

In accordance with the [Higher Education Act of 2008](#), all postsecondary institutions participating in Title IV Student Financial Aid programs have until October 29, 2011 to implement the use of the template on their Web sites or develop a customized version that must include (at a minimum) the same essentials as ED's version. The template must use institutional data to provide estimated net price information to current and prospective students and their families based on the student's individual circumstances at a particular institution.

The process for determining net price is based on first-time, full-time (FTFT) students, and therefore, is not applicable to graduate students.

Template estimates allow prospective students to calculate an estimated net price at an institution using the formula: price of attendance minus grant aid. An average net price of attendance, based on information entered by the student, is generated based on what similar students paid the previous year. An institution must determine the cost of attendance defined as the average annual cost of tuition and fees, room and board, books, supplies, and transportation for FTFT students. The institution must also determine the total need- and merit-based federal, state, and institutional grant aid awarded to FTFT students.

The estimates generated are not a final determination, actual award of financial assistance, or net price. They are only estimates based on a given year and will not be binding on the Secretary of Education, the institution of higher education, or the state.

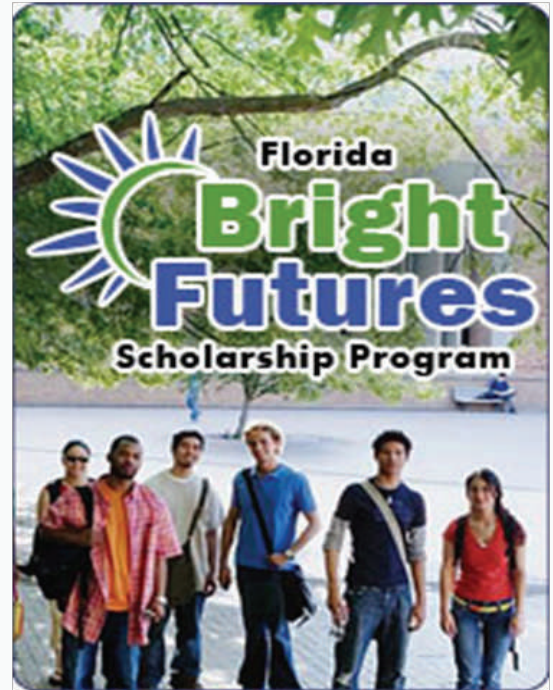

## 2010-11 Expected Family Contribution (EFC) Formula Guide

Federal Student Aid is pleased to announce the posting of the 2010-2011 EFC Formula Guide on the Information for Financial Aid Professionals Web site. The guide includes EFC worksheets and tables for the 2010-2011 processing cycle. These worksheets and tables are used to calculate an estimated EFC for students. The methodology for determining the EFC is [located](#) in Part F, Title IV, of the Higher Education Act of 1965, as amended. (HEA).

## 2010-11 ISIR Guide

Federal Student Aid is pleased to announce the posting of the 2010-2011 [ISIR Guide](#). The Institutional Student Information Record (ISIR) Guide assists financial aid administrators in interpreting student information on the ISIR. ISIRs contain processed student information reported on the Free Application for Federal Student Aid (FAFSA), as well as National Student Loan Data System financial aid history information. ISIRs are sent electronically to institutions by the Central Processing System.

## National Training for Mentors and Counselors (NT4CM)

The NT4CM workshops are off to a great start. NT4CM workshops are designed for guidance counselors and mentors who assist students and their families in preparing financially for college. Participants learn how to access free workshop resources, such as fact sheets, brochures, and Power-Point presentations. All workshop sessions are free and include up-to-date information for students and their families regarding federal and state student financial aid programs, college early awareness/planning, the FAFSA 4caster, financial literacy resources, and conducting financial aid nights.
