(What's New Continued) Goals Set For IOC

With leadership of Joel Jarrett, the new Institutional Oversight and Compliance (IOC) Director, refreshing, entrepreneurial changes are in the wind for IOC. Re-engineering of the school and lender eligibility and program participation processes is in the works. IOC has been busy compiling comparison studies of guarantors, interviewing front-line experts, analyzing markets and trends, and initiating process mapping. In the same vein of thought as Tom Peters, co-author of "Inserch of Excellence", IOC is jumping out of its box to explore the research and development possibilities of streamlining and combining similar processes with OSFA State Programs, the State Board of Independent Colleges and Universities, and the State Board of Non Public Career Education. The goal is to remove the barriers of those we serve, to maximize educational opportunities, and provide financial assistance through the Florida Federal Family Education Loan Program. HEA Drug Conviction Provision Postponed

On June 16, 1999, the U.S. Department of provided a Dear Colleague Letter, GEN-99-16: HEA Drug Conviction Provision Postponed.

The Department stated in the letter that they had received numerous inquiries that ask for their policy regarding the new drug conviction student eligibility provision in the Higher Education Act (HEA). As a result, this policy guidance was issued while awaiting the results of the negotiated rulemaking process and publication of final regulations in this area.

The drug conviction provision constitutes a new student eligibility requirement contained in section 484 of the (HEA). It provides that a student's eligibility for Federal student aid is suspended if the student is convicted, under Federal or State law, of any offense involving the possession or sale of a controlled substance (generally meaning illegal drugs, but not including alcohol or tobacco). Any such suspension of eligibility begins on the date of conviction and lasts until the end of a statutorily specified period. The suspension of eligibility ranges form one year to indefinite, depending upon the number and type of convictions. A student may regain eligibility early by completing a drug rehabilitation program that meets certain statutory and regulatory requirements (including two unannounced drug tests), or if the conviction is overturned.

All regulations related to Title IV of the HEA are subject to both the requirements of negotiated rulemaking and the master calendar provisions of HEA. As a result, final regulations establishing the criteria for acceptable drug rehabilitation programs will be published later this year and will become effective July 1, 2000.

After reviewing the legislative history of the new provision, the Department believes that Congress intended the drug rehabilitation relief provision to be available at the same time students are subject to the loss of eligibility. Members of Congress specifically indicated in statements on the floor of Congress that students should be able to regain Title IV eligibility if they complete a rehabilitation program. Thus, this new student eligibility provision will not be implemented until regulations defining an acceptable drug rehabilitation program take effect on July 1, 2000. Until that time no student will be determined to be ineligible for Title IV assistance under the new provision.

Nonetheless, a student's actions between now and the effective date of the regulations may affect eligibility. For example, a first conviction for possession of a controlled substance on February 1, 2000, will make the student ineligible for Title IV assistance from July 1, 2000 (the effective date of the regulation) until January 31, 2001 (one year from the date of conviction). If the conviction was the second for the student, eligibility would not be regained until January 31, 2002 (two years from the conviction). Because of the serious consequences to some students of the new provision and because there are certain actions that they could take to mitigate those consequences, the Department encourages, but are not requiring, you to inform your student of the new provision and help them understand how their actions might affect their future eligibility.

Students affected by the new law can avoid a loss of eligibility by completing an acceptable drug rehabilitation program. Because the final regulations defining an acceptable rehabilitation program will be published by November 1, 1999, there will be time for students to enroll in acceptable drug rehabilitation

programs before regulations become effective on July 1, 2000.

The Department also reminds you that schools need not actively question their federal student aid applicants about drug related matters. The Department plans to use the 2000-2001 aid application processes (FAFSAs and SARS) to collect needed information from applicants and to report the results to schools on ISIRs. The Department has been working with representatives from schools and colleges in their planning of these new and sensitive processes. The Department will keep all of the financial aid community updated as these plans are developed.

Time Frame for Return of FFEL Funds - Effective July 1, 1999.

The U.S. Department of Education issued a reminder on June 11, 1999, of the changes in the time frame for the return of Federal Family Education Loan (FFEL) funds.

Institutions are reminded that under Section 668.167(b) <u>Returning funds to a lender</u>, an institution must return FFEL program funds to the lender if the





Update on the Florida's State Programs

OSFA State Programs has completed the funding cycle for the 1998-99 academic postsecondary year. Programs included the Florida Bright Futures Scholarship Program, Florida Student Assistance Grants, and the Florida Resident Access Grants, just to name a few of our larger programs. We are pleased to announce the fiscal support of over \$210,000,000 to eligible students this past year.

Look for the future OSFA Outlook to include articles about Bright Futures initial eligibility criteria for the class of 2000, the many returns from the Free Application for Federal Student Aid application (FAFSA) and more. proceeds have not been disbursed to the student or parent within three business days following the date the institution receives the funds, either by means of Electronic Funds Transfer (EFT) or a master, when received after June 30, 1999.

FFEL Variable Interest Rates for July 1, 1999 through June 30, 2000.

The U.S. Department of Education released a memo June 4, 1999 for the FFEL Variable Interest Rates. On June 9, 1999, the Department issued another memo, which corrected the interest rate memo that was distributed on June 4, 1999. The June 4th memo contained an error in the interest rate formula for Consolidation Loan made before July 1, 1994. Enclosed are the charts that show the variable interest rates applicable to the Federal Stafford, Federal SLS, Federal PLUS, and Federal Consolidation loan programs for the period of July 1, 1999 - June 30,2000. Interest rates for variable-rate loans under these programs are determined annually, and are based on the bond equivalent rate of either 91-day Treasury Bills or 52-week Treasury Bills auctioned on May 24, 1999, is 4.621 percent, which rounds to 4.62 percent. The bond equivalent rate for 52-week Treasury Bills auctioned on May 25, 1999, is 4.879 percent, which rounds to 4.88 percent.

Update on the Recipient and Financial Management System (RFMS)

The Department issued an announcement on May 27, 1999 which provided an update on the Recipient and Financial Management System (RFMS).

The Department has completed their end of testing. As of May 26, 1999-2000 Electronic Statement of Account (ESOA has been sent to TIVWAN mailboxes. The ESOA's provide initial authorization amounts for institutions' GAPS accounts. Beginning on July 1, 1999, these initial authorization amounts will be available to view on the GAPS website (<u>http://gapsweb.ed.gov</u>), and will be available for you to draw from GAPS. Note that your GAPS award number has changed for the Pell Grant Program for 1999-2000 and future years. The new number will be available on ESOA.

Also, RFMS has begun accepting origination records. For those that submit origination records during the first week of production, origination acknowledgments will not be received back from RFMS before June 1, 1999.

***** Y2K Testing with the CPS

CPS will be available to schools for Y2K testing. Two six-week sessions have been scheduled for this activity. The first session is June 1 - July 12, 1999. The second session is August 9 - September 20, 1999.

The Health Resources and Services Administration (HRSA) is updating income levels used to identify a "low income family" for the purpose of providing training in the various health professions and nursing programs included in titles VII and VIII of the Public Health Service Act.

The Department periodically publishes in the Federal Register low-income levels used for grants and cooperative agreements to institutions providing training for (1) Disadvantaged individuals, (2) individuals from a disadvantaged background, or (3) low-income families. The programs under the Act that may use "low income levels" as one of the factors in determining a disadvantaged or low-income status are noted in this federal register. Also included is a table of income figures that have been updated to reflect increases in the Consumer Price Index through December 31 1998 as well as the definition of Income.

Federal Register, Department of Health and Human Services - Request for Comments for Scholarships for Disadvantaged Students, June 2, 1999.

The Health Resources and Services Administration announces that applications for fiscal year 1999 for the Scholarships for Disadvantaged Students program are being accepted under the authority of section 737 of the Public Health Service Act, Title VII, Part B, as amended by the Health Professions Education Partnerships Act of 1998, Public Law 105-392, dated November 13, 1998. This notice requesting comment on proposed eligibility criteria preferences and priorities includes updates to information provided in the January 6, 1999, program announcement.

The SDS program provides funds to health professions and nursing schools for the purpose of assisting such schools in providing scholarships to individuals from disadvantaged backgrounds who are enrolled (or accepted for enrollment) as full-time students in the schools.

Federal Register, Notice of Availability of the Amendments to the Federal Perkins Loan and National Direct Student Loan Programs Directory of Designated Low-Income Schools for Teacher Cancellation Benefits for the 1998-99 School Year, June 1, 1999.

The Secretary of Education announces that the 1998-99 Amendments to the Federal Perkins Loan and National Direct Student Loan programs Directory of Designated Low-Income Schools have been incorporated into the 1998-99 Directory currently available on the Department of Education's website. Under the Federal Perkins Loan and National Direct Student Loan programs, a borrower may have repayment of his or her loan deferred and a portion of his or her loan canceled if the borrower teaches fulltime for a complete academic year in a designated elementary or secondary school having a high concentration of students from low-income families. The 1998-99 Directory lists, on a State-by-State and Territory-by-Territory basis, the schools in which a borrower may teach during the 1998-99 school year to qualify for deferment and cancellation benefits. The Amendments to the Directory identify changes in the list of schools that qualify borrowers for teach cancellation benefits under each of the loan programs.

Federal Register, 34 CFR Part 99, Family Educational Rights and Privacy, June 1, 1999.

The Secretary proposes to amend the regulations implementing the Family Educational Rights and Privacy Act (FERPA). The amendments are needed to implement sections 951 and 952 of the Higher Education Amendments of 1998 (HEA), and to clarify several existing provisions. Comments must be received by the Department on or before August 2, 1999.

Federal Register, Privacy Act of 1974; System of Records, Notice, June 1, 1999.

In accordance with the Privacy Act of 1974, as amended, the Acting Chief Information Officer for the Department of Education publishes this Notice of a New System of Records for the Student Account Manager System, as authorized by the Higher
