1999 Policy & Training Unit

The OSFA State Programs 1998-99 Annual Report to the Commissioner will be available by the end of October. This report gives useful information and statistics on all of our State programs for the 1998-99 academic year.

Florida Student Assistance Grant (FSAG)

The FSAG Manual is currently being printed for distribution by the end of October. The updated manual lists new rules and procedures that affect administration of the Florida Student Assistance Grant. Upon receipt of the new manual, any previous manuals will be obsolete so look for them soon.

State Student Financial Aid Database Project

Our database project is well underway. We are contracting with KPMG and will share our future kick-off meeting minutes in the next OSFA Connection. Our first goal is a student application for all programs on the Web. We hope this will be available by the first of the year.

OSFA Workshop-

Our first OSFA Workshop will be held December 8-9, 1999. Sessions during this conference will address the FSAG system, Florida Bright Futures activities and an electronic access overview.

Florida Bright Futures Scholarship Program - 7th Semester--Early Notification Eligibility

Eligibility Procedures

 The current systems, the on-line system and FASTER (Florida Automated System For Transferring Educational Records) addresses 91

- (production) and 92 (practice), will continue to be used for 8th semester initial evaluation of 1999 graduates through the next 6-8 months. Next summer, those same addresses will be used for Year 2000 graduates who are being evaluated Based on all high school work.
- The on-line system and FASTER addresses 93 (production) and 94 (practice) will be used for evaluations based on 7th semester (or the term prior to the last term in high school) to be available in late November. Changes in the evaluation program for Year 2000 (removing the FAS Certificate and the GSV 24 credit method as well as adding AP and IB fine arts courses) will be completed at that time.
- Schools and districts who enter Year 2000 seniors in the 92 practice system prior to the availability of the 94 practice system will be able to move those students from 92 to 94 or may resubmit the transcripts to 94 for 7th semester early notification evaluations.
- All Year 2000 graduating students sent to production (address 93) for an early evaluation will receive a letter notifying them of their award status.
- Students will be strongly encouraged to notify the Florida Bright futures Scholarship Program (FBFSP) of their postsecondary institution choice as soon as possible after receipt of the award letter.

Eligibility Evaluation

- Student Authorization Forms must be completed by students prior to the transcript being sent to FASTER address 93 (production system).
- Students must have either completed or be enrolled in all course requirements for the scholarship.
- Transcripts may include up to 1.0 credit of courses in progress in each subject area.
- The grade point average will be based on courses completed. Courses in progress will be used to satisfy required credits only, not for grades.

Thank you for your commitment to learning our new procedures.

(Early Notification Eligibility Continued)

- We will follow the criteria approved by the State University System (SUS) for Year 2000 graduates and allow Advanced Placement (AP) and International Baccalaureate (IB) fine arts courses to be included in the additional four credits to help raise the student's grade point average for initial eligibility.
- Community service hours must be completed for all methods of qualifying for the FAS Award.
- All SAT, ACT, or CPT tests used for 7th semester early notification evaluations must be taken by January 31, 2000. The month of June will continue to be the testing deadline for students being evaluated based on all high school work.

Faster Changes for Transcript Submission to be Effective November 15, 1999

- For dual enrollment courses with an elective (EL) subject area, the evaluation program will default to the state approved subject area. If a subject area other than EL is provided on the transcript, the evaluation program will accept that specification and not use the state approved subject area.
- A FASTER message record will be sent back to the district or school when a transcript is not accepted by the Bright Futures evaluation system. A coding system will be used to indicate why the transcript was not accepted. The district or school can then correct the error and resubmit the transcript.
- The only early admission indicator that will be recognized by the FASTER system this year will be the Early Admission flag on the FASTER 101 record.
- New fields will be added to the FASTER record allowing you to transmit National Merit and National Achievement Scholar and Finalist information via the FASTER transcript.

Florida Bright Futures Scholarship Program Student Authorization Form Memo

Eligibility processing for 1999 graduates was, from our perspective, a resounding success! The evaluation of 99 percent of our applicants was complete, and colleges and students were notified of the results by the third week in August. There were a few problems, as is inevitable the first time any new procedure is implemented, but you helped us, here at DOE, and we worked through those minor glitches quickly.

Telephone System Overload

A breakdown in our toll-free telephone system occurred briefly in August because of the number of students attempting to notify us of their choice of college or university during a short period of time. We did not anticipate that most students would choose to call rather than return the Data Correction Form provided with the award letter. The overload on the telephone lines not only made it impossible for people to reach us, but also shut down the Sprint system. Sprint was concerned about this overload, too, and made every attempt to correct the situation but with much success.

We believe the implementation of our 7th semester early notification system will help to prevent a similar situation from occurring in the future. And, we will provide a means by which Year 2000 applicants will be able to access their Bright Futures records, update demographic and postsecondary institution information, and possibly view their award status through the Internet. This capability will be available next spring.

Student Authorization Form

The Student Authorization Form (SAF) and its accompanying letter to high school seniors are ready for you to distribute! Please photocopy them and give one to each senior, or early admissions student, interested in applying for The Florida Bright Futures Scholarship. The SAF, and its accompanying letter, will be on-line at www.firn.edu/doe/brfuture within two weeks. Remember, a completed SAF held on file at your school is necessary before a student's transcript may be sent to the Bright Futures Production System.

Revision to Florida Academic Scholarship and Florida Merit Scholarship Evaluation

For Year 2000 graduates, the FBFS evaluation program will be revised to conform to the State University System admissions criteria. The program will allow Advanced Placement (AP) and International Baccalaureate (IB) Fine Arts courses to be included in the additional four credits that can be used to help raise the student's grade point average for initial eligibility.

7th Semester Early Notification

The 7th Semester Early Notification Evaluation Program will be ready by early December. Until then, you may continue to use the current 8th semester evaluation system. Details regarding the 7th Semester Early Notification Evaluation Program are enclosed.

Instructions For and Enhancement to the Initial Eligibility (IE) System

We strongly encourage you to change the password to your on-line system every few months to maintain secure information.

Please remove the 1999 graduates from the practice system if you are finished with them. Use the same practice system, as soon as you would like, to begin entering transcripts for your Year 2000 graduates. Make sure the students know that the Florida Academic Scholars Certificate and Gold Seal Vocational Scholars 24 credit methods are no longer valid. (These methods are identified on the evaluation report as FASC and GSV-U).

The IE program has been enhanced with:

- A new view screen to provide you with the date(s) and type(s) of letter(s) sent to the student (identified on the student list with action button "V").
- The ability to selectively transfer transcripts to production (identified on the student list with action button "X").
- Course flag fields on the course edit screen to be used to designate courses in progress for 7th semester--early notification evaluations (identified on the course edit screen with action button "E").

Examples of these are included for you.

Regional Training

Regional training workshops for all high school guidance counselors will be held in late November and early December. Dates and locations will be determined very soon.

Brochures

Our informational brochure with detailed scholarship requirements is on its way to the printer. We plan to provide you with enough to give one to each and every student in your high school (grades 9-12). Look for them soon!

NSLDS SSCR Y2K Contingency

The Department of Education issued a Dear partner Letter on October 4, 1999, titled NSLDS SSCR Y2K Contingency, which stated that the Department will be taking a precautionary measure to help insure that the computer systems of all parties involved in enrollment data processing will be immune from Y2K in difficulties. Under this one-time schedule change: All schools (or their servicers) will receive an SSCR file in the beginning of November. This will provide schools/servicers a reasonable recent enrollment status should there be a disruption in reporting come January. Schools will have the usual 30 days to respond to the file and 10 days to correct any errors. Rosters will be produced in January and all subsequent months according to schools' SSCR schedules, just as before. Please review your SSCR schedule using the NSLDS on-line screens.

CONFERENCES AND TRAINING High School and TRIO Counselor Workshops

The U.S. Department of Education announced a series of one-day federal student aid workshops for High School and TRIO counselors. The workshops will be presented from October 1999 through January 2000, the Department will offer forty one-day workshops nation-wide.

Topics include Induction to Student Financial Assistance Programs and General Student Eligibility Criteria, Completing the 2000-2001 Free Application for Federal Student Aid, Hands-on overview of applying electronically through FAFSA on the Web, Getting the Results, What the College Does, and Where to Find Information. Other topics include a review of the federal financial aid delivery system and how an expected family contribution is calculated.

Description ED Announcement on FY97 Official Cohort Default Rates.

The Department mailed the FY 1997 Official Cohort Default Rates to schools via overnight mail on September 29, 1999. The FY 1997 official cohort default rates represent those borrowers that have entered into repayment on certain Federal Family Education Loan (FFEL) and William Ford Federal Direct Loan (DL) Program loans during FY 1997 and defaulted (or met other specified conditions) during FY 1997 or FY 1998. ❖ GEO: Default Rates Need to Be Computed More Appropriately

The U.S. General Accounting Office released a report titled "Student Loans: Default Rates Need to Be Computed More Appropriately." The following are portions of the cover letter and the "Results in Brief". The full report can be found on NASFAA's website.

COVER LETTER

Two major federal student loan program, the Federal Family Education Loan program (FFELP) and the William D. Ford Federal Direct Loan program (FDLP), provide funding that is vital to helping students meet their postsecondary education costs. FFELP, formerly known as the guaranteed student loan program, provides loans through private lenders such as banks. These loans are insured against default by state or nonprofit guaranty agencies, which are later reimbursed by the Department of Education. FDLP, often referred to as the direct loan program, provides loans from the federal government through

Students' schools. The first FDLP loans were made in the fourth quarter of fiscal year 1994. The Department uses student borrowers' experiences with loans from FFELP and FDLP for determining a school's default rate.

IN fiscal year 1998, these programs provided student borrowers with nearly 8.4 million loans totaling more than \$30 billion. However, when borrowers fail to meet their financial obligations by not repaying their federal student loans, it is the government that ultimately must pay for this failure. For example, the Department of Education paid \$2.1 billion in default claims from these programs in fiscal year 1998. An accurate measure of student loan defaults at colleges, universities and vocational schools is an important means for monitoring the extent of financial risk to the Department form its student loan programs. To protect the government from the costs associated with extremely high rates of default, the Department now excludes schools from program participation if their default rate is 25 percent or more for 3 consecutive years.

You asked us to examine one aspect of the way in which the Department calculates this default rate. The issue involves borrowers who have temporary approval through their lenders or loan services through "deferment " or "forbearance" not to make payments on their loans. In the Department's calculation of a school's default rate, these borrowers are not counted as defaulters, but they do count as a part of the total number of borrowers. The number of borrowers in default is divided by a number larger than the total number of borrowers who are actually repaying their loans. As a result, the default rates are understated.

As agreed with your offices, we focused our work on answering three specific questions with regard to these calculations:

- Over the past several years, has there been an increase in the number of borrowers who entered repayment but subsequently received deferments or forbearances?
- What would have been the effect on the most recent default rates if borrowers whose loans were in deferment or forbearance had been excluded from the default rate calculation?
- Under this alternative method of calculating the default rate, would any additional schools have exceeded the 25-percent default rate threshold?

(Default Rates Need to Be Computed More Appropriately Continued)

Between 1993 and 1996, the percentage of borrowers with loans in deferment or forbearance more than doubled, from 5.2 percent of borrowers who had begun repaying to 11.3 percent. This doubling was consistent across the various types of schools, including 4-year and less-than-4-year public and private schools as well as proprietary schools. According to Department of Education officials, the increase was attributable, in part, to provisions of the 1992 amendments to the Higher Education Act of 1965 that eased the requirements for obtaining deferments and forbearances as a way of helping minimize loan defaults.

Excluding borrowers with loans in deferment or forbearance entirely form the calculation of the cohort default rate would have had the effect of increasing the overall default rate form 9.6 percent to 10.9 percent for 1996, the most recent cohort year for which data are available. The proportional increases would have been roughly similar for the various types of schools. For example, the rate at 4-year schools would have risen from 6.8 to 7.7 percent, while the rate at proprietary schools would have risen from 18.3 to 20.1 percent.

For the 1996 cohort, excluding borrowers with loans in deferment or forbearance form the calculation would have increased the number of schools with rates exceeding the 25-percent threshold (for excluding schools from the loan programs) by 181 schools, from 352 to 533--an increase of 51 percent. Under the law, these schools would have become ineligible to participate in student loan programs if their cohort default rate had exceeded the threshold for 3 consecutive years. Since 1991, the Department has denied participation in the programs to more than 1.000 schools because their default rates were too high. Most of the additional schools that would have exceeded the threshold under the alternative calculation method were proprietary schools, but 12 were 4-year colleges and universities and 57 were public or private schools with degree programs of less than 4 years. Because of the number of borrowers with loans in deferment or forbearance has been growing, and because the exclusion of these borrowers from the calculation could have a substantial effect on schools' default rates, the Congress may want to consider requiring an alternative method for computing default rates.

Review of Federal Student Financial Aid Regulations

As part of an ongoing process for improving the student financial assistance regulations and in preparation for a report to be submitted to Congress in October, the Department of Education is reviewing its regulations relating to student financial aid. As part of that review, the Department solicited the views of customers and partners - including students, schools, and financial institutions to listening sessions that were held in September. These listening sessions were intended to surface regulatory issues, to identify regulatory sections in need of improvement, and to talk about an ongoing process for regulatory reform.

Following the listening sessions, the Department will synthesize the information collected, as well as their own analysis of the regulations, and present it in a report to Congress in October. The initial report will chronicle the issues identified at the listening sessions and outline the process for continuing the Department's work on regulatory reform.

Reminder About Use of PINs in 1999-2000

The Department issued a friendly reminder that the Department will be mailing PINs (formerly known as Electronic Access Codes or EACs) instead of paper Renewal FAFSAs to students who in 1999-2000 filed web applications or who indicated on their FAFSAs that they were a 5th year undergraduate or a graduate student. In addition, the Department will mail PINs to those students for whom you requested (through the Renewal Application process) that the Department mail PINs instead of paper Renewal FAFSAs.

This mailing will take place between November 22, 1999 and December 31, 1999. Electronic filings have dramatically lower error rates than do the paper versions, so the Departments hopes you will remind your students, either through email distribution or through your publications process, that these PINs will be coming to their permanent mailing address. The Department also hopes you will inform your students that these PINs can be used to access their financial aid history through the National Student Loan Data System and the Direct Loan Servicing System.

ED to Permit Students to Make Some FAFSA Corrections on the Web.

The U.S. Department of Education is proud to announce Corrections on the Web for the 1999-2000 school year. This new feature will allow students to make address, phone number, and college choice corrections on the web using an Electronic Access Code (EAC, soon to be renamed PIN). Corrections on the Web are available on the FAFSA on the Web sit (http://www.fafsa.ed.gov) and will NOT require that a student submit a paper signature.

In March 2000, the Department will also bring online a full correct feature for the 2000-20001 school year that will allow students to make corrections to all fields on their Student Aid Report (SAR) with the exception of their Social Security Number and Date of Birth.

Electronic Access Guide

The U.S. Department of Education is pleased to announce the electronic release of the Electronic Access Guide on the IFAP web site (www.ifap.ed.gov).

The Electronic Access Guide is a reference provided to schools participating in electronic aid processing for the first time. It gives an overview of the steps required to successfully exchange data with ED's data processing centers as well as the implications of using this process along with the school's own operations and equipment. Nine school profiles, along with descriptions of how they implemented electronic processing of financial aid data at their schools, are included. For further information, call (800) 330-5947.

Guidance for Helping Title IV Participants Affected by Hurricane Floyd.

The Department of Education recognizes the severe impact that Hurricane Floyd and its aftermath has had on Title IV participants located in Federally declared natural disaster areas. The Secretary wishes to assist the victims of the hurricane in their recovery by providing certain regulatory relief to students, schools, lenders, and guaranty agencies in their administration of the student financial aid programs under title IV of the Higher Education Act of 1965, as amended. This relief is generally applicable to the 1999-2000 award year (July 1, 1999 to June 30, 2000).

Dear Colleague Letter GEN-99-27 supplements the Dear Guaranty Agency letter, published on August 5, 1999 as Disaster Letter 99-28, which provided to lenders and guaranty agencies separate guidance on handling borrowers who are in repayment and have been affected by a natural disaster. Loan holders have been authorized to grant affected borrowers an administrative forbearance for up to three months based on a borrower's request for assistance. A Title IV participant that deviates from otherwise required actions in its administration of the Title IV program on the basis of the guidance in GEN-99-27, must document that fact and indicate what alternative procedures were followed. The Secretary provides guidance and enforcement relief from regulatory requirements in GEN-99-27.

The Secretary believes that it is in the best interest of the FFEL Program to consider each Federal Stafford loan that has not entered repayment and that was not in a default status on the date the borrower's attendance at the school was interrupted due to the disaster to be (or have been) in an "in-school" status and to continue in that status until the school resumes normal operations. This period of disaster-related nonattendance should not result in a borrower entering or using any of his or her grace period.

The Secretary authorizes lenders not to disburse loan proceeds to schools in the affected area according to the originally established disbursement schedules as required, if they have been informed that a school has delayed opening for a scheduled term or has ceased operations for an undetermined period of time. Lenders should await revised disbursement schedules from the affected schools.

The Secretary has provided waivers applicable to FFEL schools located in a disaster area. The Secretary will allow modified timelines for the return of undisbursed funds as specified under the Cash Management section of GEN-99-29. The Secretary will also not enforce the usual deadline for schools to complete and submit required student status confirmation reports to the Secretary or guaranty agency within 30 days of the school's receipt of the report. The Secretary will instead require completion and submission of these reports within 90 days.

To assist participants in complying with the guidance provided in GEN-99-27, the Florida Office of Student Financial Assistance has attached a copy of this letter for your reference.

Department of Education's Approval of the Federal PLUS Loan Application Materials.

The Department issued a Dear Guaranty Agency Director letter, GEN-99-28, which serves as the Department of Education's approval of the Federal PLUS Loan application materials. The application materials include the following documents:

- Application and Promissory Note for Federal PLUS Loan
- Instructions for Completing Federal PLUS Loan Application and Promissory Note
- Borrower's Rights and Responsibilities
- Endorser Addendum to Federal PLUS Loan Application and Promissory Note
- Instructions for Completing Endorser Addendum to Federal PLUS Loan Application and Promissory Note.

The PLUS loan application materials have been revised to include changes made to the Federal Family Education Loan Program by the 1998 Amendments to the Higher Education Act of 1965. The new application materials also incorporate suggestions made by the financial aid community in response to the Department's May, 1999, request for comments. While changes were made to the text of the application materials, no changes were made to the data collection items. Since the new application materials reflect changes made to the Higher Education Act, agencies and lenders should implement them as soon as possible. At the latest, the new application materials must be used for application issued on or after March 1, 2000. Complete old PLUS forms received by lenders after that date may be processed.

Economic Hardship Deferment Request Form Errors.

It has been brought to the attention of the U.S. Department of Education, that there is an error on one of the Worksheets associated with the recently approved Economic Hardship Deferment Request form On Worksheet B, Step 3, Item (2) refers to "TOTAL AMOUNT BORROWED from Step 3" in two different places. Actually, the total amount borrower is calculated in Step 2, not Step 3.

In addition, the Economic Hardship Deferment Request form that was provided earlier contained an incorrect OMB number. The OMB number for all of The Federal Family Education Loan (FFEL) Program deferment forms are 1845-0005.

The Department has corrected these errors and our office has enclosed a copy of the corrected Economic Hardship Deferment Request form as well as a corrected copy of the Worksheet B.

The Florida Office of Student Financial Assistance had previously provided a copy of the new approved deferment forms. Enclosed in this newsletter is a copy of the corrected Economic Hardship Deferment Request form.

Student Loan Cohort Default Rate for Fiscal Year 1997.

Secretary of Education, Richard Riley gave a statement October 5, 1999, regarding the student loan cohort default rate for fiscal year 1997. Secretary Riley stated that the national rate is 8.8 percent, the lowest ever. A declined for seven straight years since its peak of 22.4 percent in fiscal year 1990.

Secretary Riley feels that default rates are more than an indicator of the health of the student aid programs, that the lower default is one of the many ways that student aid has been strengthened over the past six years:

- Students have saved nearly \$9 billion through lower loan fees and interest rates;
- Taxpayers have saved over \$5 billion thanks to the creation of the Direct Student Loan program and smaller subsidies on guaranteed loans; and
- The Department has expanded student aid opportunities, including providing larger Pell grants; one million work-study opportunities; the new Hope and Lifetime Learning tax credits for higher education and training; and the Gear Up and Trio initiatives to help disadvantaged students prepare for college success.

Although these are important improvements, Riley is concerned that Congress is writing a budget that undercuts these accomplishments, rather than building upon them. The House proposal ends dedicated funding for class-size reduction; cuts afterschool and reading initiatives; eliminates 64,000 college work-study slots; and provides not one dime to help disadvantaged children succeed in college through Gear Up or to help school districts replace the nation's aging and overcrowded schools. The Senate proposal, while a bit better in some areas, still eliminates the priority for class size and under-funds vital investments in education.

The Higher Education Act of 1965, as amended, provides that the Federal share of awards under the Federal Supplemental Educational Opportunity Grant Program may not exceed 75 percent of such awards. The non-Federal share of FSEOG awards shall be made from an institution's own resources, including institutional scholarships and grants, tuition or fee waivers, State scholarships and grants, and foundation or other charitable organization funds. In response to inquiries concerning the use of State scholarships for this purpose, the Department has determined that all State scholarships and grants, except for Leveraging Educational Assistance Partnership awards, are eligible funds that may be used to meet the non-Federal share requirement. LEAP awards, for this purpose, are defined as the Federal LEAP allocation plus the minimum required State matching amount. The remaining State grant amounts are considered non-LEAP awards and therefore can be used to meet the non-Federal share requirement.

❖ Dear Financial Aid Administrator, CB-99-16, Campus-Based Programs Funding Formula Changes for the 2000-2001 Award Year, September 1999.

The Higher Education Amendments of 1998 made several changes to the funding formulas that are used to calculate awards made to institutions that participate in the Campus-Based programs. This letter details those changes and explains how your institution's Federal Perkins Loan, Federal Work-Study, and Federal Supplemental Educational Opportunity Grant program funding allocations for award year 2000-2001 will be calculated. In addition, this letter requests that you verify the enclosed new 2000-2001 guarantee for each of the Campus-Based programs for your institution.

❖ Dear Colleague Letter, GEN-99-25, Action Letter #4, September 1999.

This letter is a follow-up to Action Letter #1 (June 1999) on the 2000-2001 Renewal Application Process. It provides step-by-step instructions and tips to schools wishing to request electronic files and/or printed materials for the 2000-2001 Renewal Free Application for Federal Student Aid.

❖ Dear Colleague Letter, ANN-99-9: October 7, 1999 SFA Satellite Videoconference, September 1999.

❖ Federal Register, 38 CFR Part 21, Increased Allowance for Educational Assistance Test Program, Final Rule, August 17, 1999.

The law provides that rates of subsistence allowance and educational assistance payable under the Educational Assistance Test Program shall be adjusted annually by the Secretary of Defense based upon the average actual cost of attendance at public institutions of higher education in the twelve-month period since the rates were last adjusted. After consultation with the Department of Education, the Department of Defense has concluded that the rates for the 1998-99 academic year should be increased by 5% over the rates payable for the 1997-98 academic year. The regulations dealing with these rates are amended accordingly. This rule is effective as of august 17, 1999.
